1. INTRODUCTION

I am pleased to be writing to you with details of our Annual General Meeting which we are holding at the Institute of Directors, 116 Pall Mall, London, SW1Y 5ED at 1.30pm on 21 June 2018. The formal notice of the Annual General Meeting is set out on pages 6 to 8 of this document.

The purpose of this letter is to provide Shareholders with details of, the background to and reasons for, the resolutions to be proposed at the AGM, to explain why the Board believes that the passing of the Resolutions is in the best interests of Eden and the Shareholders as a whole and to recommend that Shareholders vote in favour of the Resolutions. The Resolutions to be proposed at the AGM include, amongst other things, resolutions to authorise the Directors to allot new Ordinary Shares and to dis-apply statutory pre-emption rights on the allotment of new Ordinary Shares.

If you would like to vote on the Resolutions but cannot attend the AGM, please complete the Form of Proxy enclosed with this document and return it to Link Asset Services, PXS 1, 34 Beckenham Road, Beckenham, BR3 4ZF as soon as possible and, in any event, so as to be received by no later than 1.30pm on 19 June 2018.

2. BUSINESS TO BE TRANSACTED AT THE AGM

Details of the resolutions which are to be proposed at the Annual General Meeting are set out below.

Ordinary resolution 1: Annual Report 2017

The business of the Annual General Meeting will begin with a resolution to lay before members the Annual Report in respect of the year ended 31 December 2017 (the "Annual Report 2017"). Shareholders will have the opportunity to put questions on the Annual Report 2017 to the Directors before the resolution is proposed to the Annual General Meeting.

Ordinary resolution 2: Re-appointment of auditors

Shareholders will be asked to confirm the re-appointment of KPMG LLP as the Company's auditors to hold office until the conclusion of the next annual general meeting and to grant authority to the Directors to determine the auditors' remuneration.

Ordinary Resolution 3: Re-election of Director

Shareholders are asked to re-elect as a Director, Alex Abrey, who is voluntarily retiring and who, being eligible, is offering himself for re-election.

Ordinary Resolution 4: Re-election of Director

Shareholders are asked to re-elect as a Director, Lykele van der Broek, who is voluntarily retiring and who, being eligible, is offering himself for re-election.

Ordinary resolution 5: Grant of authority to the Directors to allot Ordinary Shares

At last year's annual general meeting of the Company, shareholders passed a resolution giving the Directors authority to allot Ordinary Shares. That power expires following the conclusion of the Annual General Meeting and the Directors therefore propose that the relevant authority is renewed and increased at the Annual General Meeting and, accordingly, have proposed resolution 5 in the Notice of Annual General Meeting to do this.

It is proposed that the Directors be authorised to allot Ordinary Shares up to a maximum nominal value of £729,123.54 (representing 72,912,354 Ordinary Shares) which is approximately equal to 33.3 per cent. of the Company's issued share capital and share capital in respect of which options, warrants or other rights to subscribe for Ordinary Shares have been granted as at 24 May 2018 (being the latest practicable date prior to publication of this document).

Special resolution 6: Disapplication of statutory pre-emption rights on allotment of shares

Pursuant to Resolution 5, the Directors are seeking authority to allot equity securities or sell treasury shares for cash up to a maximum aggregate nominal value of £218,956.02 (representing 21,895,602 Ordinary Shares) which is approximately equal to 10 per cent. of the issued share capital of the Company and share capital in respect of which options, warrants or other rights to subscribe for Ordinary Shares have been granted as at 24 May 2018) without first offering the securities to existing Shareholders. The total number of Ordinary Shares in issue as at 24 May 2018 (being the latest practicable date prior to the publication of this document) is 207,189,337. The Company does not currently hold any treasury shares. The proposed resolution also dis-applies the statutory pre-emption provisions in connection with a rights issue and allows the Directors, in the case of a rights issue, to make arrangements in relation to fractional entitlements or other legal or practical problems which might arise.

This authority would expire at the conclusion of next year's annual general meeting.
